Conditions of Certification

1. When applied to a non combustible substrate.
2. Consisting of: composite of acrylic resin (polymethyl methacrylate) and natural mineral (aluminium trihydrate). Total dry thickness half inch, 12mm, density $\geq 1.68\text{g/cm}^3$.
3. Composition of individual components, layers and manufacturing process, to be maintained in production in accordance with originally tested sample.
4. The Certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products are fully compliant with the relevant statutory regulations as applicable and are designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
5. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D), a Product-Quality assurance system (Module E) or a Product Verification Process (Module F). The wheelmark cannot be affixed to the product until a conformity assessment module is in place.
6. Each item, batch or lot of the equipment is to be issued with a "Declaration of Conformity" and have the "Mark of Conformity" affixed after a conformity assessment module is in place.
7.
